CONTRACT DATES:

Your F/W/S contract will take effect Tuesday September 3rd, 2024 and runs **36 weeks**, through June 14th, 2025. **The week of ROI and 3 weeks of practices is not included in your 36 week contract.**

CONTRACT REGISTRATION

- Balances will be divided into 9 equal payments. They are due on or before the 1st of each month.
- Your payment schedule is as follows: Active now registration date, October 1st, November 1st, December 1st, January 1st, February 1st, March 1st, May1st, June 1st.

CANCELED DATES:

There are several times during the skating season where there will be no ice or off-ice classes. These dates will be credited on your Active online account after registration.

The following are dates known at print time:

SERVICE HOURS:

During the 2024-2025 Fall, Winter, Spring and Summer Sessions **all** 1st club members are required to work or pay a service hour fee. This requirement must be met by June 14th, 2025. If you need further information regarding service hours, please contact Katie Callahan at kate.callahan@gm.com.

All families must volunteer for 4 hours(2 shifts) at our Annual Competition, October 11-12, 2024.

At the time of registration, the service hour fee of \$100 is due from **all** 1st Club members. It will be credited back to your account once 30 service hours have been completed. Those not contracting must still turn in the \$100 service hour fee by September 1st, 2024.

-Service hours are your responsibility. A form is outside the club office or a link is available online. Only donations for competition and ice show and other club events can be used as monetary donations towards hours (ex: you cannot just pay money in lieu of hours). It is required that part of your hours consist of two shifts at Shores Autumn Classic.

IMPORTANT! Before any contract is submitted, you must make sure your account is not in arrears.

LATE PAYMENTS:

- Each payment is automatically withdrawn via Active account. If your payment does not go through it is the skater/parent responsibility to adjust the payment method and/or contact the Treasurer or President to work out arrangements for the payment method.
- If no attempt to make a new payment has been made after a **3 day grace period a \$35.00 late fee** will be charged to your account..
- Anyone in arrears will be denied ice time, test sessions and competition privileges. It is our obligation to report any delinquent skaters to USFSA. You will not be able to go to competitions or to other clubs if you are in arrears with the club or your coach. If you are having trouble with your online payments please contact us ASAP.
- NSF: Members will be notified and a new check must be submitted within 7 days of notification. A \$45 fee will be charged on all NSF checks. If a second check is declared NSF on skater's account the following procedure will be implemented: The member will be notified, a new payment must be made in cash, money order or certified check, and Only cash, money orders or certified checks will be accepted on the account for a period of 12 months, following the second infraction.

Reflections on Ice 2025 April 25, 26, 27th, 2025

The 2025 Reflections on Ice Show is open to all club skaters. New information for the 2025 show will be announced at a later date. The cut off for test level for solo / feature / groups will be our test session prior to ice show sign up. Any test taken after this date will not be recognized for ice show purposes.

IMPORTANT: A reminder that all skaters who have passed the Pre Preliminary FS test must contract and **skate** a minimum of **3 on ice sessions** per week during the F/W/S contract in order to participate in Reflections on Ice and Basic Skaters must **contract** for at least 1 session per week.



MEMBERSHIP MEETINGS:

Three General Membership Meetings are held each year for your voice and are open to all members. Meetings will be held in October, January and May. Please attend and get involved with your club. You must attend at least 1 meeting per year.

ON ICE SESSIONS:

FS: Freestyle. Offered 6 days a week for individual practice and or private lessons contracted with a club professional of your choice. In order to choose your level of skating you must have passed the Freestyle for which you are contracting.

Open: Open Sessions. This session will be open to all skating levels.

OFF-ICE SESSIONS:

Strength Training: Certified Trainers supervising skating specific programs using plyometrics, balance exercises, aerobic workouts, resistance, weights and stretching.

*Proper attire: Gym clothes and gym shoes.

Ballet: Class is designed to promote knowledge of correct body alignment. Helps improve coordination of the body with musicality and rhythmic accuracy.

*Proper attire: Skating dress or leotard and tights or skating pants, hair pulled away from face & ballet slippers preferred.

Dance: Skaters will be exposed to contemporary, lyrical, jazz and hip hop dance styles.

Flexibility- Classes will focus on giving the skater stretches to improve their flexibility

Skating Skills- Skaters will work on specific skating positions in an off ice class

ICE FEES

Fall/Winter/Spring 2024-2025. Pricing will be done by packages, which are listed below.

The more ice you purchase, the cheaper your rate per hour will be. The F/W/S program consists of **36 weeks**. Your total ice bill will be divided into 9 payments. All payments are due on the 1st of each month beginning October 1st and ending June 1st. (no payment April 1st) The first payment is due at the time of registration.
